In view of the hazards on some shopfloors, you will be instructed on specific rules prior to your visit there.

GENERAL RULES ON OUR PREMISES

Upon entering our premises you will receive a visitor card.

When an accident occurs on our premises immediately inform the mill safety service by calling the phone number **03862-20-155**.

For personal and general safety reasons it is not allowed to drink any alcoholic beverages or to enter our premises under the influence of alcohol, legal drugs or illegal drugs.

Carrying with you or consuming alcoholic beverages or taking drugs on our premises is forbidden.

General prohibition of taking pictures or of filming. This also applies to camera phones.

The use of mobile phones is not permitted in some areas specifically identified at our premises.

Comply with our waste separation system.



Also observe any local danger signs such as:

PERSONAL PROTECTIVE EQUIPMENT

Required for visits in our shopfloors:

- Safety helmet
- Solid and closed shoes
- Ankle-length trousers
- Outer garments with long sleeves

We recommend wearing safety shoes (with toe protection)



The following equipment can and will be made available to you during your visit:

Safety helmet (with an integrated eye protection); specially certified helmets may be used. Glass-fibre reinforced helmets are required in our warm and hot mills.



Visitor coat



If required:

Ear protection



Safety goggles or an eye protection which is integrated into the safety helmet



Special equipment

Permanently flameproof clothes required e.g. in the electric steel mill. Please observe our instructions throughout your visit.

VEHICLE TRAFFIC

The Austrian Road Traffic Regulations apply on our premises.

Speed limit is 30 km/h.

Be aware of radar controls!



The works own traffic always takes priority!

You must at all times be prepared for inter-factory transport by rail, by fork lift and by other transportation vehicles and above all for transport with hot goods and dangerous goods.

Strictly comply with the no stopping and no parking zones!

Never block entrance roads to the fire brigade and ambulance! Parking particularly in front of fire hydrants, gateways, gates or any other narrow points and on sewer covers is not allowed. Offences against these provisions may result in a ban on driving on our plant grounds.
